SUBJECT: NOTICE OF VICLATION (NRC INSPECTION REPORT NO. 50-413/86-16 AND 50-414/86-17)

This refers to the Nuclear Regulatory Commission (NRC) security inspection conducted on March 25-26, 1986 at your Catawba Nuclear Station, Units 1 and 2, in York, South Carolina. This inspection was in response to your telephone notification to us on March 21, 1986, regarding a security incident that occurred on March 21, 1986. The findings of our inspection were discussed with you during an Enforcement Conference held in the Region II Office on April 24, 1986.

The first violation involves an incident in which the integrity of a vital area barrier was lessened when a steel plate (Emergency Air Penetration Flange) which exceeds ninety-six (96) square inches was removed from the barrier wall, and adequate security measures to prevent unauthorized access to the vital area were not established. A second violation was identified and reported on March 3, 1986, by the NRC Resident Inspector which was also investigated during this inspection and is included as part of this report. This violation involved an open equipment hatch which was not under control of a security officer and through which access to a vital area could be gained.

In accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," 10 CFR Part 2, Appendix C (1986), the violations described in the enclosed Notice have been classified as Severity Level III and Severity Level IV violations, respectively. Normally, a civil penalty is considered for a Severity Level III violation. However, after consultation with the Director, Office of Inspection and Enforcement, I have decided that a civil penalty will not be proposed in this case because of your prompt identification and reporting, in the area of access control to vital areas.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice,






