MEETING REPORT - ENERGY INCORPORATED, MARVIKEN SUPPORT WORK UNDER CONTRACT NO. AT(10-1)-1456 - JANUARY 14, 1974

On January 14, 1974 a meeting was held between members of the Containment Systems Branch and representatives of EI. This contractor is in the last month of a program effort that will be completed by January 31, 1974. The status of the work as it was discussed at the meeting was as follows:

ON-SITE PARTICIPATION

The on-site participation in the Marviken Project has been discontinued as of December 18, 1973, at which time the EI representative returned to Idaho Falls to participate in the report preparation.

STATISTICAL ANALYSIS

The statistical analysis has been completed and a draft of the final report was presented at the meeting. This draft contained all the changes suggested on December 14, 1973, in Bethesda. EI will proceed with the printing of 75 copies to be submitted to Containment Safety for further distribution to the Marviken participants.

FINAL REPORT

Several chapters of the final report, that is being prepared for the AEC, were reviewed at the meeting. A number of suggestions were made on those chapters, as well as on the scope of those still in preparation. It was agreed that a complete draft of the final report would be available and forwarded for receipt by Containment Safety on January 21. Recommendations and suggested changes will be incorporated until January 24 such that the printing of the report can be completed by February 1, 1974.
