Gentlemen:

This refers to your letter dated November 18, 1985, for renewal of Materials License 06-16699-01.

We received your check for \$460. Your application, however, is subject to renewal fees totalling \$1,510 as specified in fee Categories 3B (\$460), 3N (\$930), and 3P (\$120) and Footnote 1(c) of \$170.31 of revised 10 CFR 170, copy enclosed. Footnote 1(c) states, in part, that "Applications for renewal of materials licenses and approvals must be accompanied by the prescribed renewal fee for each category.....". Fee Category 3B pertains to the portion of your license authorizing manufacturing for commercial distribution, fee Category 3N pertains to service for other licensees (installation), and fee Category 3P pertains to leak testing. Payment of the additional \$1,050 should be made to the U.S. Nuclear Regulatory Commission and mailed to my attention at our Washington, D.C. address.

Your application will be processed by the Region I Licensing staff located at 631 Park Avenue, King of Prussia, Pennsylvania 19406. The additional fee, however, is required prior to issuance of the renewal. When submitting the fee, please refer to CONTROL NUMBER 104665.
