Dear Mr. Wright,

Thank you for your prompt review of our application to amend the above referenced license.

Amendment 15 of our license permits the use of Xenon 133. We are not currently using Xenon for any studies and will not use Xenon during the temporary relocation of the two nuclear medicine imaging rooms. When the Nuclear Medicine Department is moved to it's permanent location on the first floor, in 6 to 9 months, we will again apply to amend our license for the move and for the use of Xenon.

As we discussed today, cur renovation schedule is as follows:

September 22nd -- Move both GE Nuclear cameras to renovated area.

September 24th -- A close out survey will be performed. A copy of this survey

or will be sent to you. The doors to the hot lab and to 25th cardiac imaging will be closed and sealed from the new construction area. The other door to the hot lab will be

opened.

September 29th -- Construction workers will be given access to the closed out imaging rooms to continue with the construction project.

Thank you for your verbal approval to amend our license and proceed with the schedule detailed above.
