Subject: PROPOSED IMPOSITION OF CIVIL PENALTY - \$5,000

This is to inform the Commission that a Notice of Violation and Proposed Imposition of Civil Penalty in the amount of Five Thousand Dollars (\$5,000) will be issued on or about December 4, 1986 to Gamma Diagnostic Laboratories. This action is based on several violations involving failure to properly secure or maintain control of licensed material located in delivery vehicles, failure to properly post and control access to a high radiation area, failure to perform adequate surveys, and failure to instruct and provide appropriate dosimetry to contractor workers entering a restricted area.

It should be noted that the licensee has not been specifically informed of the enforcement action. The Regional Administrator has been authorized by the Director, Office of Inspection and Enforcement, to sign this action. The schedule of issuance and notification is:

A news release has been prepared and will be issued after the licensee receives the Notice. The State of Massachusetts will be notified.

The licensee has thirty days from the date of the Notice in which to respond. Following NRC evaluation of the response, the civil penalty may be remitted, mitigated, or imposed by Order.
