The enclosure is tabulated chronologically by Georgia Power Company's submittal date. Georgia Power is prepared to discuss modifications to this status report and will promptly address any questions you may have regarding these licensing issues.

During the past month the NRC has completed licensing action on:

- 1) our January 6, 1986, proposed Technical Specifications change which would increase the allowable time for scram discharge volume vent and drain valve closure;
- 2) our February 6, 1987, proposed Technical Specifications change related to boron concentration in the standby liquid control system;
- 3) our February 13, 1987, proposed Technical Specifications change related to scram speed testing and fuel operating limits; and
- 4) our March 4, 1987, proposed Technical Specifications change related to hydrostatic and leak testing with a non-critical core.

Georgia Power Company acknowledges and appreciates these efforts.

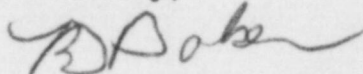
