Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. 552, the Government Accountability Project (GAP) requests copies of any and all agency records and information, including but not limited to notes, letters, memoranda, drafts, minutes, diaries, logs, calanders, tapes, transcripts, summaries, interview reports, procedures, instructions, engineering analyses, drawings, files, graphs; charts, maps, photographs, agreements, handwritten notes, studies, data sheets, notebooks, books, telephone messages, computations, voice recordings, computer runoffs, any other data compilations, interim and/or final reports, status reports, and any and all other records relevant to and/or generated in connection with the inspection conducted by Mr. R.P. McIntyre of the Nuclear Regulatory Commission (NRC) on August 25-29, 1986 of the office of Stone & Webster Engineering Corporation, New York, New York, to review the implementation of Stone & Webster's Quality Assurance (QA) program concerning activities relating to the Design Requalification of piping and pipe supports of Comanche Peak Units 1 and 2, and to the discussions of the NRC's findings with Mr. Carl Watters and members of Stone & Webster at the conclusion of the inspection.


