[REDACTED] wanted to inform Mr. Noonan of the termination of two women by Brown and Root. [REDACTED] said the first woman was terminated after being accused of drug involvement. The second woman was terminated after coming to her defense. She states that both women are innocent and were not allowed to take a lie detector test. She stated that she thinks TUGCO's drug investigation and use of the lie detector test is a way of getting rid of whistleblowers. She stated she had no safety concerns.
