
APPLICANTS' ANSWER TO MOTION TO

On June 16, 1987, the Applicants received "Attorney General James M. Shannon's Motion to Compel Applicants to Produce Documents and Answer to Applicants' Motion for a Protective Order." This submission concerns Mass. AG's desire to obtain a copy of the IDYNEV computer model used by KLD Associates. As Applicants stated in their letter to the Mass. AG on April 6, 1987: "Applicants are informed that FEMA owns the model and that KLD will reproduce it only upon receipt of a proper release from FEMA." Mass. AG has also been specifically informed by counsel for the Applicants


