However, pending completion of all required closeout requirements, it is necessary to deobligate excess funds remaining under this contract for other immediate agency requirements. Therefore, this modification is issued to deobligate unexpended funds in the amount of \$17,218.70 which thereby decreases the obligated amount of this task order from \$197,746.11 to \$180.527.41.
