ENFORCEMENT GUIDANCE MEMORANDUM - GUIDANCE ON THE

RELEASE OF OI SYNOPSES IN DISCRIMINATION CASES

Allegation Guidance Memorandum 98-01, dated January 27, 1998, discusses the release of Office of Investigation (OI) synopses concerning investigations of discrimination to parties to Department of Labor (DOL) proceedings. The guidance states that once the Office of Enforcement (OE) has approved releasing the OI findings to the parties to the DOL hearings, the responsible region or office will prepare the transmittal letters. In the interest of consistency, OE has prepared a model letter to be sent to licensees, contractors or vendors when OI investigations have either substantiated or not substantiated discrimination allegations and there are pending DOL proceedings on similar matters. Copies of the synopses of the OI reports are made available to the parties in the DOL proceedings and these parties are informed that the complete report may be requested under the Freedom of Information Act. We are providing the parties involved in the DOL hearing the results of the OI investigation. A copy of the synopsis of the OI report is enclosed. You should note that final NRC documents, including the final OI report, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information provided under FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records.
