This refers to the routine inspection conducted by Mr. David Nelson and Dr. Ross Landsman on March 4, 1998, at the Northeast Ohio Regional Sewer District Southerly Wastewater Treatment Plant. The purpose of the inspection was to determine whether activities at the site were conducted safely and in accordance with NRC requirements.

The enclosed copy of our inspection report identifies the areas examined during the inspection. Within these areas, the inspection consisted of observations made during a tour of the North and South Fill Areas located within and south of the Southerly Wastewater Treatment Plant, and interviews with Northeast Ohio Regional Sewer District and B.
