Under Section B.2, Consideration and Obligation--Cost Plus Fixed Fee (June 1988) Alternate I (June 1988), paragraph c. is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"The amount presently obligated by the Government with respect to this contract is \$366,700.00."
