
1. The State proposes to correct a statement made by Ms. Curran at page 137, line 2 to change "sure shipments" to "Shorham shipments." This correction should instead read "Shorham shipments."

2. The State proposes to correct a statement made by Mr. Silberg at page 147, lines 17-18 to change "The Shore and Limerick Shipping" to "The Shoreham to Limerick shipments." Applicant had also proposed a correction to this phrase, but will agree to the State's proposed correction instead.
3. The State proposes to correct a statement made by Mr. Silberg at page 194, line 16 to change "before as" to "before, and." Applicant believes that this correction should be "before, and as."
4. At page 245, line 25, the State proposes to delete "Lawrence White" from those present for the State of Utah and to add "246." Applicant believes that "246" should not be added.
5. The State proposes to correct a statement made by Mr. Blake at page 780, line 10 to change "contention's" to "contentions." Applicant believes that the correction should be "contention."


