



In accordance with your letters dated February 27, 1980 and September 9, 1980, signed by W.S. Shelley, Director Regulation and Control, the subject license is amended to add conditions:

- 32. Operation of an Ion Exchange Plant located at Church Rock I Mine, TI7N, RI6W, McKinley County, New Mexico, is authorized in accordance with subject letters noted above, attachments to those letters and the following conditions.
- 33. a) Radioactive material shall be used by individuals designated in writing by the Radiation Safety Officer for Church Rock Operations, Mr. Mark Brekhus, or his designated alternate.
- 34. In the event of an accidental spill of radioactive material, concurrence of the Division is required for the final soil decontamination level.
