**SUPPLEMENTARY INFORMATION:** On June 30, 2020 (85 FR 39049), the NRC published a direct final rule amending its regulations in part 72 of title 10 of the *Code of Federal Regulations* to revise the TN Americas LLC, Standardized NUHOMS® Horizontal Modular Storage System listing within the "List of approved spent fuel storage casks" to include Renewed Amendment No. 16 to Certificate of Compliance No. 1004.
