The enforcement conference will be held at the City/County Health Department, Third Floor Conference Room, 4616 East 15th Street, Tulsa, Oklahoma, on September 22, 1987, at 10:00 a.m. to address the findings of the inspection referenced above and to gain your response to these findings.
