Gentlemen:

Please find enclosed Amendment No. 14 to your NRC material license. You should review this amendment carefully and be sure that you understand all conditions. If you have any questions, you may contact the reviewer who signed your license amendment at 817/860-8100.

You must prepare and submit a decontamination survey report for the nuclear medicine area and any other areas where licensed materials were used or stored. Please pay careful attention, in preparing the report, to the instructions in the enclosed 1982 guide, entitled "Guidelines for Decontamination of Facilities and Equipment Prior to Release for Unrestricted Use or Termination of Licenses for Byproduct, Source, or Special Nuclear Material." Be certain to identify your wipe test results in terms of disintegrations per minute (not counts per minute). Key the results to specific points on a facility diagram. Indicate the detection equipment that was used to assay the wipes, the method used to calibrate this equipment, and the date of calibration.

Upon receipt of a satisfactory decontamination survey report, we will issue a fee exempt amendment to your license that will authorize you to release the old facility for unrestricted use.

Please be advised that you must conduct your program involving radioactive materials in accordance with the conditions of your NRC license, representations made in your license application, and NRC regulations. In particular, note that you must:

- Operate in accordance with NRC regulations 10 CFR Part 19, "Notices, Instructions and Reports to Workers; Inspections," 10 CFR Part 20, "Standards for Protection Against Radiation," and other applicable regulations.
- Possess radioactive material only in the quantity and form indicated in your license.
- Use radioactive material only for the purpose(s) indicated in your license.

- 4. Notify NRC in writing of any change in mailing address (no fee required if the location of radioactive material remains the same).
- 5. Request and obtain appropriate amendments if you plan to change ownership of your organization, change locations of radioactive material, or make any other changes in your facility or program which are contrary to your license conditions or representations made in your license application and any supplemental correspondence with NRC. A license fee may be charged for the amendments if you are not in a fee-exempt category.
- 6. Submit a complete renewal application with proper fee, or termination request at least 30 days before the expiration date on your license. You will receive a reminder notice approximately 90 days before the expiration date. Possession of radioactive material after your license expires is a violation of NRC regulations.
- 7. Request termination of your license if you plan to permanently discontinue activities involving radioactive material.

You will be periodically inspected by NRC. A fee may be charged for inspections in accordance with 10 CFR Part 170. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the General Policy and Procedures for NRC Enforcement Action, 10 CFR Part 2, Appendix C. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which the NRC expects of its licensees.


