Dear Mr. Miraglia:

Mr. Ed Tomlinson of the NRC staff met with District staff at Rancho Seco on June 2 and 3, 1987. The purpose of the meeting was to discuss the District's response to NRC Question 16 in the District's April 1, 1987 (JEW 87-358) submittal "Proposed Amendment No. 147, Rev. 2." Specifically discussed was the conformance of the Nuclear Service Electrical Building (NSEB) and Diesel Generator (DG) Building electrical installation to Regulatory Guide 1.75.

Prior to the meeting, the District prepared a draft report documenting the conformance of the NSEB and DG Building electrical installation to Regulatory Guide 1.75. The draft report was used as a basis for the discussions with Mr. Tomlinson. Based on these discussions and Mr. Tomlinson's comments, the report has been revised. Attached is the final report (ERPT-E0220, Rev. 0) documenting the District's conformance, prior to restart, to Regulatory Guide 1.75 for the NSEB and DG Building electrical installation.
