


- 5. G.5, Contract Ceiling, is hereby deleted in its entirety and replaced with the following in lieu thereof:

"G.5 Contract Ceiling

The present estimate for performing the work under this contract and the total amount obligated is \$30,000.00. The contract ceiling specified above may be increased by the Contracting Officer from time to time by written notice to the contractor. When and if the amount(s) paid and payable to the contractor hereunder equal the ceiling, the contractor shall be excused from further performance of the work (except to meet existing commitments and liabilities) unless and until the Contracting Officer increases the amount obligated under this contract. If and to the extent that such ceiling has been increased, any costs incurred by the contractor in excess of the ceiling prior to its increase shall be allowable to the same extent as if such costs had been incurred after such increase in the ceiling."

As a result of this contract modification No. 4, the total contract ceiling and the obligated amount is hereby increased by \$15,000.00 from \$15,000.00 to \$30,000.00.

All other terms and conditions of this contract shall remain unchanged.
