Gentlemen:

Your letter of September 20, 1988 transmitted a Temporary Change to the Calvert Cliffs Nuclear Power Plant, Units 1 and 2, Security Plan under the provisions of 10 CFR 50.54(p). This change is a revision to the Temporary Change transmitted by your letter dated April 29, 1988, and provides an alternate method for ensuring full security during the ongoing security system upgrade program. It is understood that upon completion of the work which necessitates the Temporary Change, it will be rescinded and you will revert to the commitments in your current NRC-approved Security Plan.

We have reviewed this Temporary Change and have determined that it is consistent with the provisions of 10 CFR 50.54(p), and is considered acceptable.

The enclosure to your letter is being withheld from public disclosure since it contains Safeguards Information, and must be protected in accordance with 10 CFR 73.21.
