SUBJECT: MINUTES OF CRGR MEETING NUMBER 121

The Committee to Review Generic Requirements (CRGR) met on Wednesday, August 26, 1987, from 1-4 p.m. A list of attendees for this meeting is enclosed (Enclosure 1). The following item was addressed at the meeting:

1. T. L. King (RES) presented for CRGR review proposed NUREG-1226, "Development and Utilization of the NRC Policy Statement on the Regulation of Advanced Nuclear Power Plants." The Committee recommended that the NUREG should be endorsed by the EDO, after several clarifying changes to be coordinated with the CRGR staff, and then forwarded to the Commission for final approval. The Committee also recommended that one change to the Commission's Policy Statement itself be considered. This matter is discussed in Enclosure 2.
2. R. Bernero (NMSS) presented for CRGR consideration proposed criteria for determining which NMSS items should be provided for CRGR review under the Charter. The Committee agreed with the approach presented. This matter is discussed in Enclosure 3.
3. There was a brief discussion of the CRGR Long-Range Agenda. It was agreed that the CRGR staff will work jointly with NMSS, NRR and RES in finalizing the Agenda.

In accordance with the EDO's July 18, 1983 directive concerning "Feedback and Closure on CRGR Reviews," a written response is required from the cognizant office to report agreement or disagreement with CRGR recommendations in these minutes. The response, which is required within five working days after receipt of these meeting minutes, is to be forwarded to the CRGR Chairman and if there is disagreement with the CRGR recommendations, to the EDO for decisionmaking.
