This is in response to the two submittals of June 5, 1987, filed by you on behalf of Toledo Coalition for Safe Energy, Sunflower Alliance, Inc., Susan B. Carter and Steven Sass. Specifically, these submittals were (1) a "Petition of Toledo Coalition for Safe Energy, Sunflower Alliance, Inc., Steven Sass and Susan B. Carter for Revocation, Modification or Suspension of Operating License per 10 C.F.R. §2.206," and (2) "Sunflower Alliance's Motion to Reopen the Record and to Submit a New Contention". The submittals alleged that the Reed Report (a 1975 General Electric Company (GE) Reactor Study) identified problems with GE nuclear facilities such as the Perry facility of the Cleveland Electric Illuminating Company, et al. Specific deficiencies were alleged and a suspension of facility operation was requested pending an exhaustive review of the issues raised in the Reed Report. On June 30, 1987, I informed you that these submittals had been referred to my Office for consideration pursuant to 10 CFR 2.206 and that a formal decision would be issued in the reasonably near future.

For the reasons set forth in the enclosed Director's Decision under 10 CFR 2.206, your request has been denied. A copy of the Decision will be referred to the Secretary for the Commission's review in accordance with 10 CFR 2.206. For your information, I have also enclosed a copy of the notice regarding this Decision filed with the Office of the Federal Register for publication.
