JOINT STIPULATION CONCERNING JI CONTENTION 8

The Attorney General for the Commonwealth of Massachusetts ("Mass AG"), the Town of West Newbury ("TOWN") and Applicants hereby submit the following Joint Stipulation, which is intended to resolve the issues raised in JI Contention 8.

The Stipulation

Applicants agree to include the following additional information in EBS messages to be broadcast during an evacuation:

B903170121 B90228 PDR ADDCK 05000443

- ETAs for transit-dependent buses, for each Massachusetts a) town being evacuated; and
- instructions to the transit-dependent population not to b) go outdoors until the buses are to arrive.

Applicants further agree to add the following language to the section entitled "Emergency Buses" in the next published Emergency Plan Information Calendar.

"If you miss any bus call the help number identified on the first page of this calendar."

In light of these revisions, Mass AG and the TOWN agree that the issues raised in JI Contention 8 have been resolved. Mass AG and TOWN accordingly withdraw JI Contention 8.
