The purpose of this modification is to provide incremental funds as indicated below.

1. Section G.11 Consideration, paragraph "B" is revised to read as follows:

"B. The total funds currently available for issuance of individual task orders under this contract is increased by \$200,000.00 from \$2,800,000.00 to \$3,000,000.00. For further provisions on funding, see the Limitation of Funds Clause 52.232-22 referenced in Part II - Contract Clause, Section I."

All other terms and conditions, including the ceiling amount of \$5,240,000.00, shall remain the same.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
