The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, interviews, and review of your investigation report pertaining to the fitness-for-duty issue.

Your independent investigation of the senior manager's fitness for duty appears to have been adequate in scope and depth. Based on that investigation and our onsite inspection, we conclude that while there is reasonable assurance that the senior manager was fit for duty, the absence of empirical test results prevents an absolute determination of his fitness for duty. We also conclude that the senior manager's actions relating to plant matters were appropriate and that safe operation of the Clinton plant was not adversely affected because of this fitness-for-duty issue.

No violations of NRC requirements were identified during the course of the inspection. These weaknesses warrant review on your part to identify specific actions to further improve your fitness-for-duty program. We request that you inform us, in writing within 30 days of the date of this letter, of the corrective actions you will take for the weaknesses.

The allegation addressed in this report demonstrated that plant employees and supervisors are sensitive to the need for a workplace free of the effects of alcohol and will properly report perceived violations of that requirement, even if it involves senior managers. That represents a strength in your overall program.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC Public Document Room.
