Gentlemen:

We have reviewed Addendum 1 to ANF's Fundamental Nuclear Material Control Plan (FNMCP) submitted under your letter dated July 29, 1987, and titled "Safeguards Plan for Solid Waste Uranium Recovery Facility." We have determined that the Safeguards Plan is acceptable and that incorporating it as a condition of license will not adversely affect the common defense and security nor the public health and safety and is otherwise in the public interest. Accordingly, we are revising License Condition 1.1 of Amendment SG-2 to your License No. SNM-1227, effective immediately, as shown below.

- 1.1 The licensee shall follow Chapters 0.0 through 8.0 and Appendix A of its Fundamental Nuclear Material Control Plan, submitted pursuant to 10 CFR 74.31(b), titled "Nuclear Materials Safeguards Procedures Description for the Fuel Fabrication Plants," designated "XN-12, Revision 17," and dated October 1986, except for pages 1-8, 1-12, 1-13, 1-14, 1-23, 1-24, 4-2, 4-48, 4-51, 5-1, 5-2, 5-4, 5-5, 5-7 through 5-11, 7-16, through 7-34, 8-3, 8-6, and 8-7, all of which are dated March 1987. The licensee shall also follow Addendum 1 (Rev. 0, pages 1 through 12 dated July 1987) to this Plan. Revisions to this Plan shall only be made in accordance with the provisions of either 10 CFR 70.34 or 70.32(c).

We have determined that the enclosure to your letter, dated July 29, 1987, contains information of the type specified in 10 CFR 2.790(d). Accordingly, pursuant to Section 2.790(d)(1), such information is deemed to be commercial or financial within the meaning of 10 CFR 9.5(a)(4) and shall be withheld from public disclosure unless subject to the provisions of 10 CFR 9.12.
