REPORT FOR JULY 27 - AUGUST 2, 1987

1. DEFUELING

Pick and place defueling of partial length fuel assemblies continued. Partial fuel assemblies E-2, E-10 and H-2 were loaded into defueling canisters. Fuel assembly F-10 has been freed but not placed in a defueling canister. A total of 60 fuel assemblies have been loaded into canisters.

Three canisters were transferred to storage racks in the deep end of the refueling canal in the reactor building for temporary storage.

2. ENVIRONMENTAL MONITORING

 US Environmental Protection Agency (EPA) sample analysis results show that TMI site liquid effluents are in accordance with regulatory limits, NRC requirements, and the City of Lancaster Agreement.

TMI intake water and water effluents from the station (Units 1 and 2) discharge are analyzed by EPA. Gamma spectrum analyses of the seven daily composited samples for July 11 - 18, 1987 indicated no reactor related activity.

 EPA's gamma spectrum analysis of the NRC's TMI outdoor air sample for July 22 - 31, 1987 showed no reactor related radioactivity.

 The water works for the City of Lancaster composited seven daily samples from July 12 - 18, 1987. EPA's gamma spectrum analysis of the composite sample showed no reactor related radioactivity.
