

The purpose of this modification is to revise the Consideration clause of the contract to increase the amount of funds allotted for the performance of the on-going support task, and to decrease the amount of funds allotted for performance of task orders by \$70,000.00. Accordingly, the following change is applicable.

A. Paragraph G.1 Consideration - subparagraph A.3 is deleted in its entirety, and the following paragraph is substituted in lieu thereof.

"3. Total funds currently available for payment and allotted to this contract are \$270,391.82 for the on-going effort and \$62,203.47 for performance of task orders."

B. All other terms and conditions of the contract remain unchanged.
