Gentlemen:

This refers to the inspection conducted by Mr. J. B. Baird of this office and other accompanying personnel during the period October 13-16, 1987, of activities authorized by NRC Operating License NPF-38, for the Waterford 3 Steam Electric Station, and to the discussion of our findings with Mr. R. P. Barkhurst and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included the implementation of the emergency plan and procedures during the annual emergency response exercise. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the NRC inspector. The inspection findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.

The enclosed report identifies four deficiencies in your emergency preparedness program observed during the emergency exercise. You are requested to provide this office a schedule for correcting these deficiencies within 30 days after receipt of this letter.

We also examined actions you have taken with regard to previously identified inspection findings. The status of these items are identified in paragraph 2 of the enclosed report.


