On May 30, 1998, the Nuclear Regulatory Commission (NRC) completed an inspection at your McGuire Nuclear Station. The enclosed report presents the results of that inspection.

During the six-week period covered by this inspection, your conduct of activities at the McGuire facility was generally characterized by safety-conscious operations, sound engineering and maintenance practices, and careful radiological work controls. Work activities associated with the beginning of the Unit 1 scheduled refueling outage were conducted without adverse impact to operating systems on both units.



