

CROWNPOINT IN SITU PILOT TEST  
SECTION 9, T17N, R13W  
RADON DATA

Dear Mr. Stewart:


Since September 1979, Mobil Oil Corporation, Uranium/Minerals Division has been taking continuous radon-222 measurements at the Crownpoint Project. These measurements have been taken on the SW/4 of Section 9, T17N, R13W in conjunction with the pilot uranium in situ test being performed in that same quarter section. The measurements have been taken using an Eberline RGM-1. Attached for your records are listings of the average daily and monthly radon concentrations measured by the RGM-1 at this location.

These data are for the period January 1, 1981 through March 31, 1981. As samples continue to be taken, additional data will be submitted as they become available. The raw data tapes and listings of hourly averages are kept on file at our office.

These data indicate slightly higher radon concentrations for this 1981 period as compared to the same period in 1980. The values are within an expected range when climatic conditions for the two periods are considered. The environmental scientist at the Milan EID office confirmed similar concurrent findings in the area.
