NUREG-1275, "Operating Experience Feedback Report: New Plants," documents a detailed review by the NRC staff of the cause of unplanned events during the early months of operation for nuclear plants licensed between March 1983 and April 1986. This report included the major lessons and corrective actions that appear to have the greatest potential for improving the effectiveness of plant startups. Although sent to TVA previously (see references), I am enclosing another copy and wish to specifically call to your attention the section on Improvement Lessons for Consideration by Licensees (pages xviii through xxi).

We request that you provide us a written response, within 45 days of the date of this letter, of specific actions TVA has taken or plans to take at Sequoyah with respect to these Improvement Lessons.

The reporting and/or recordkeeping requirements contained in this letter affect fewer than ten respondents; therefore, OMB clearance is not required under P.L. 96-511.
