Dear Mr. Roe:

This letter is to officially advise the Commission of a change in the Combustion Engineering Quality Assurance Program described in our Topical Report CENPD-210-A.

Effective September 21, 1987, Power Systems Group nuclear quality assurance functions were consolidated within the Nuclear Power Systems Division in a new Nuclear Quality Systems department. This new department is now responsible for all quality functions previously accomplished by Group Quality Assurance, Engineering Quality Assurance and Customer Service Quality Assurance. As a result, certain organizational titles have been changed. This re-organization does not diminish our commitment to quality as described in CENPD-210-A.

Table 1 depicts the relationship between quality assurance functions and organizational titles currently in CENPD-210-A and the new organizational titles. Table 2 contains an organization chart showing the reporting relationships of Nuclear Quality Systems.

Holders of controlled copies of the Nuclear Quality Assurance Program Manual have already been informed of these changes. A copy of this letter is, however, being sent to these same individuals for information.
