Gentlemen:

You were recently notified in a letter dated June 16, 1987, by the NRC Region V office that a one-page revision (Figure 1-1) to your Fundamental Nuclear Material Control Plan (FNMCP), which you submitted as a 70.32(c) change, was acceptable and consistent with the provisions of 10 CFR 70.32(c). Thus, we are revising License Condition 2.1 of your Safeguards Amendment SG-1 to your License No. SNM-696 to include the identification of such revision.

We are also revising License Condition 9.1.C of SG-1 to correctly identify the current applicable revisions of your Security Officer Training and Qualification Plan. The change to Condition 9.1.C was discussed by Keith Asmussen (of GA) and Don Joy (of my staff) and was mutually agreed upon.

Revised Conditions 2.1 and 9.1.C are effective immediately and read as follows:

- 2.1 The licensee shall follow Revision A of his "Fundamental Nuclear Material Control Flan," dated October 1982; as revised by the following submittals:
 - 1. Submittal of August 17, 1984 (pages 3-6, 3-7, 3-8b, 3-8c, 3-8d, 3-8f, 4-4, 4-6b, 4-7, 4-17, 4-19a, and 4-20 --- all dated "August 1984"),
 - Submittal of December 21, 1984 (pages 4-4a, 4-5, and 4-19 --- all dated "August 1984"),
 - 3. Submittal of January 25, 1985 (Figure 2.1.1-2 --- dated "January 1985"),
 - 4. Another January 25, 1985 submittal (pages 7-7 through 7-9 --- all dated "February 1985"),

- 5. Submittal of December 5, 1985 (pages 1-1, 1-5, 1-7, 1-8, 1-10, and 4-1, --- all dated "December 1985"),
- Submittal of March 7, 1986 (pages 1-6, 2-2, 3-2, 3-8a, 3-8e 4-8, 4-18, 5-1, 5-4 through 5-7, 6-2, 6-4 through 6-6, 7-1, 7-3 through 7-6, and Figures 2.1.1-1, 6.1.1.1, and 6.1.1.2 --- all dated "February 1986").
- 7. Submittal May 22, 1986 (pages ix, x, 1-2 through 1-4, 1-9, 2-1, 2-3 through 2-5, 2-7, 3-8, 4-2, 4-3, 4-8, 5-2, 6-1, 6-3, 6-7, 6-8, 7-16, 7-18, and 8-1 through 8-4 --- all dated "May 1986"),
- 8. Submittals of August 5 and 13, 1986 (pages 3-1, 5-3, and 7-10 through 7-21 --- all dated "August 1986"), and
- 9. Submittal of December 10, 1986 (Figure 1-1 --- dated "November 1986").

This Plan may be further revised pursuant to the provisions of 10 CFR 70.32(c).

9.1.C The licensee shall follow the plan, "GA Technologies, Inc.. Security Officer Training and Qualification Plan," dated March 1983, as revised by submittals dated March 19, 1983, March 5, 1986 (pages 1, 3-3, and 3-4), May 23, 1986 (pages 3-2, 4-1, 4-2, and Figures 1.1 and 1-2), and August 5, 1986 pages 3-1 and 6-1, and Figure II 1-3); and as may be revised in accordance with the provisions of 10 CFR 70.32(e).
