Please find enclosed an amendment to your NRC Material License.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the Region I Material Licensing Section, (215) 337-5239, so that we can provide appropriate corrections and answers.

Please be advised that you must conduct your program involving licensed radioactive materials in accordance with the conditions of your NRC license, representations made in your license application, and NRC regulations. In particular, please note the items in the enclosed, "Requirements for Materials Licensees."

As per our telephone conversation with Kathleen H. Quenelle on May 6, 1986, we will not approve your request for alternative methods for naming users as stated in Items 1, 2, and 3 of your April 16, 1986 letter. However, we are sending you a letter under separate cover suggesting an alternative method which is acceptable to the NRC. Please refer to Control No. 105371 when responding to our letter.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, the NRC expects licensees to pay meticulous attention to detail and to achieve the high standard of compliance which the NRC expects of its licensees.


