I think I can safely say that the majority of the people of Sonoma do not want an Atomic Power Plant on Bodega Head because Californians know how devastating earthquakes can be.

My personal opinion is that Pacific Gas & Electric Utility Co. has no moral right to even apply for a permit to build an Atomic Power Plant on Bodega Head when they - by their own admission - propose to sit their reactors in splintered rock within 1000 feet of the San Andreas Fault. That is not in my opinion safe.

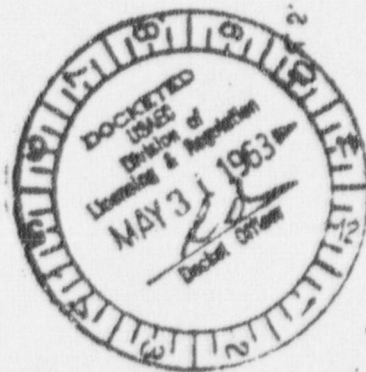
