Dear Sir/Madam:

I am writing to request an amendment to our Broad Scope Type A byproduct materials license pertaining to our license condition for annual refresher training. We are currently obligated to conduct refresher training every year. However, our program experiences very few significant changes during the course of a year. In addition, our user base consists mostly of very experienced researchers who transferred to FDA from the NIH program. We have only introduced one or two new users per year for the past several years. Further, the overall number of active investigators has steadily decreased over the past five years, as researchers who intended to use materials have since decided to discontinue their use.

In the past year our Radiation Safety Officer, CAPT Noska, has been using blanket email messages to communicate important information to all users in a timely fashion with success. While we do typically use refresher training to review important radiation safety concepts, we believe that the experience level of our users, combined with other forms of engagement (i.e., laboratory inspections, package deliveries, waste pickups, etc.) ensures that our users maintain good radiation safety practices in their laboratories. Therefore, we are asking to amend our license such that we are only required to deliver formal refresher training on a biennial basis.
