Discussion: On July 6, 2020, the licensee provided NRC Form 314 and five additional disposal records. Records indicated that an authorized contractor disposed of gauges. The shipping records did not specify which gauges belonged to which license. Licensee was asked to provide clarification of disposed gauges in order to verify that all license material was disposed from each location as the shipping records indicate that all shipments were made from the same location. Licensee was not sure how to obtain this information. Inspector mentioned that their records should have that information. Licensee said they understood the request and would provide a response.
