This letter transmits our report of the routine resident safety inspection by Messrs. R. A. Gramm and R. L. Fuhrmeister on February 13 to March 26, 1989 at the Limerick Generating Station, Unit 2, Limerick, Pennsylvania of activities authorized by NRC License No. CPPR-107 and to the discussions held by the inspectors with Messrs. W. T. Ullrich, A. S. MacAinsh and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the enclosed NRC Region I Inspection Report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel and observations by the inspectors.

No violations were identified and no response to this letter is required.

The Limerick Generating Station Unit 1 and Unit 2 resident inspector offices have been combined under a single Senior Resident Inspector, Thomas Kenny. Subsequent resident inspection reports will be issued as combined reports for both Unit 1 (Docket No. 50-352) and Unit 2 (Docket No. 50-353). Specialist inspections will continue to be single unit reports for the present time.
