1. Procedure EPP 06-011, "EMERGENCY TEAM FORMATION AND CONTROL," Rev. 13

Procedure EPP 06-011 revision conforms to changes being made to EPF-06-018-09 and EPF 06-018-12 which relocates/reorganizes inventory items for the Off-Site Monitoring Teams to expedite team dispatch. The change is administrative/editorial in nature.

The change does not reduce the effectiveness of the Emergency Plan.

2. Form EPF 06-018-009, "OFF-SITE MONITORING INVENTORY CHECKLIST," Rev. 10
