

2. Subsection B.2 - Consideration and Obligation--Firm Fixed Price is hereby increased by \$75,000.00 for the option period, from \$75,000.00 to \$150,000.00 as follows:

"B.2 CONSIDERATION AND OBLIGATION--FIRM FIXED PRICE (MAR 1987)

The firm fixed price of this contract is \$150,000.00. Payment will be made upon completion/delivery and acceptance of all required products/services in accordance with Section F of this contract."
