This letter refers to the routine safety inspection conducted by Mr. R. K. Mathew of this office on May 1-5, 1989, at the Calvert Cliffs Units 1 and 2, Lusby, Maryland of activities authorized by NRC License Nos. DPR-53 and DPR-69 and to the discussions of our findings held by Mr. Mathew with Mr. L. Russell at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region 1Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. These violations have been categorized by severity level in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions, "10 CFR Part 2, Appendix C (Enforcement Policy)." You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

In addition, it is important that proper management attention be given to the MOV maintenance program deficiencies identified in this report. We understand that you are in the process of implementing a new program to address current deficiencies. During the inspection, your staff agreed to provide the NRC a written description of plans to upgrade the MOV maintenance programs.
