Gentlemen:

This refers to the inspection conducted by Messrs. R. E. Farrell and P. W. Michaud of this office during the period January 1-31, 1989, of activities authorized by NRC Operating License DPR-34 for Fort St. Vrain Nuclear Generating Station, and to the discussion of our findings with you and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included licensee action on previously identified inspection findings, operational safety verification, monthly surveillance observation, monthly maintenance observation, and core safety limit. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. The inspection findings are documented in the enclosed inspection report.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. Since corrective action was promptly initiated, completed, and verified by the NRC inspector prior to the completion of this inspection, no written response is necessary.

We have also examined actions you have taken with regard to previously identified inspection findings. The status of these items is identified in paragraph 2 of the enclosed report.

The response directed by this letter and the accompanying Notice is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
