We have reviewed our existing license for accuracy and relevance to our current program, in accordance with the suggested alternative application renewal procedure cited in the reference above.

Our program remains essentially unchanged from that reflected in our current license as amended in amendments No. 05 dated March 31, 1983 and No. 06 dated September 29, 1983.

Our program continues to be restricted to the possession of Hydrogen 3 sealed sources, each not exceeding 3 curies and the total of all such sources not exceeding 24 curies.

Reference is made to Amendment No. 05, page 1. David M. Reilly continues to be the primary supervisor of licensed material use. However, Kathryn B. McHenry is no longer associated with the radiation safety program and the name John C. Tormey, Safety Administrator should be substituted. The undersigned has been associated with our radiation Safety program at the Electro-Optics Division since 1978.

Our consulting Radiochemist continues to be Murray M. Bolton Jr., who conducts the required wipe tests and provides consulting services as needed. Our facilities, security and radiation protection procedures, including periodic inventories, remain unchanged, except that we have discontinued the use of film badges, in as much as our activity is limited to the use of sealed sources.
