Gentlemen:

Presently, two NRC licenses are held by Saint Elizebeths Hospital of the National Institute of Mental Health in Washington, D.C. These facilities have been previously controlled by the federal government only. However, as of October 1, 1987, per Public Law 98-621, it is the intent of the District of Columbia to govern the Blackburn Laboratory facility. When bringing this transaction to the attention of your agency, several items required responses from our facility. Upon this request, I submit the following:

- 1. Will the name of either institution change? Yes, the Blackburn Laboratory will come under the Commission on Mental Health Services. The Wm. A. White Building will remain under the National Institute of Mental Health.
