Gentlemen:

LILCO has completed a multi-discipline review of the document transmitted by the reference letter considering the NRC Staff's current practice of Technical Specification (TS) Certification. Members of the SNPS Plant Staff, Nuclear Quality Assurance Department, Nuclear Engineering Department and Nuclear Operations Support Department participated in this review.

Please be advised that the organization chart that appears in the Technical Specification Administrative Control Requirements (Figure 6.2.1-1) is not consistent with the new corporate organization described in SNRC-1558.

In anticipation of such organization changes, LILCO has submitted License Change Application #14 to remove organization charts from the Technical Specification Administrative Control Requirements in accordance with the guidance of Generic Letter 88-06. This request was submitted via SNRC-1465, dated June 13, 1988. LILCO expects NRC Staff will approve this change request after the issuance of a full power license.






