NOTICE OF VIOLATION

Navajo Agricultural Products Industry  
Farmington, New Mexico

Docket: 30-12751/89-01  
License: 30-17435-01

During an NRC inspection conducted on June 22, 1989, a violation of NRC requirements was identified. In accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," 10 CFR Part 2, Appendix C (1988), the violation is listed below:

10 CFR 30.41(c) requires that, prior to transferring licensed material, each licensee verify that the transferee's license authorizes the receipt of the type, form, and quantity of byproduct material to be transferred. 10 CFR 30.41(d) specifies the requirements for verifying authorization.

Contrary to the above, on September 15, 1987, 50 mCi of americium-241 in a Campbell Pacific Nuclear Model 503 moisture/density gauge, Serial Number H380G2370 was transferred to the Bureau of Indian Affairs, Navajo Area, without utilizing one of the verification procedures.

This is a Severity Level IV violation. (Supplement VI)

Pursuant to the provisions of 10 CFR 2.201, Navajo Agricultural Products Industry is hereby required to submit to this office, within 30 days of the date of the letter transmitting this Notice, a written statement or explanation in reply, including for each violation: (1) the reason for the violation if admitted, (2) the corrective steps which have been taken and the results achieved, (3) the corrective steps which will be taken to avoid further violations, and (4) the date when full compliance will be achieved. Where good cause is shown, consideration will be given to extending the response time.
