## Gentlemen:

LILCO has announced a number of personnel and organizational changes at the Shoreham Nuclear Power Station.

Please be advised that LILCO has reviewed the changes to ensure that qualified personnel continue to carry out the duties and responsibilities of positions described in licensing basis documents such as the SNPS Updated Safety Analysis Report. The following paragraphs describe these changes. LILCO concludes that the personnel designated to carry out the duties and responsibilities of the positions described below meet or exceed the qualification requirements described in the licensing design basis.

First, I, John D. Leonard, Jr. have been assigned Vice President-Corporate Services. The Office of Nuclear will be headed by William E. Steiger, Assistant Vice President - Nuclear, who is an Officer of the Long Island Lighting Company and has the duties, responsibilities and authority that I had, except as explained below. Mr. Steiger will report to LILCO's President and Chief Operating Officer, Mr. Anthony F. Earley, Jr.

Effective August 1, 1989, my new responsibilities, three of which are directly related to Shoreham, will include the following:
