CRGR MEETING NO. 169 - REVISED AGENDA

The Committee to Review Generic Requirements (CRGR) will meet in the afternoon on Wednesday, September 13, 1989, in Room 2F-17, OWFN. The agenda is as follows:

- 1:00-2:00 p.m. B. Morris (RES) will present for CRGR review the proposed final Policy Statement on Maintenance. (The review package is enclosed.)
- 2:00-3:00 p.m. B. Morris (RES) will present for CRGR review a proposed final rule on Nuclear Power Plant Access Authorization Programs. (A revised package will be provided by RES in advance of the meeting.)
- 3:00-4:00 p.m. L. Shao (RES) will present for CRGR review proposed Revision 3 to Reg. Guide 1.35, "Inservice Inspection of UngROUTed Tendons in Prestressed Concrete Containments," and proposed Reg. Guide 1.35.1, "Determining Prestressing Forces for Inspection of Prestressed Concrete Containments." (The review package is Item No. 7 distributed to CRGR members on August 24, 1989.) RES REQUESTED THAT THE CRGR REVIEW OF THIS ITEM BE RESCHEDULED UNTIL OCTOBER 11.
- 4:00-5:00 p.m. J. Richardson will present for CRGR review a topical report and a proposed safety evaluation report (SER) that approves application of the results of an industry-initiated research program on conduit fire seals. (The review package is enclosed.) REVIEW OF THIS ITEM IS CANCELLED. CRGR REVIEW IS NOT REQUIRED UNDER THE CHARTER.

If a CRGR member cannot attend the meeting, it is his responsibility to assure that an alternate, who is approved by the CRGR Chairman, attends the meeting.

Persons making presentations to the CRGR are responsible for (1) assuring that the information required for CRGR review is provided to the Committee (CRGR Charter - IV.B), (2) coordinating and presenting views of other offices, (3) as appropriate, assuring that other offices are represented during the presentation, and (4) assuring that agenda modifications are coordinated with the CRGR contact (J. Conran X29855) and others involved with the presentation. Division Directors or higher management should attend meetings addressing agenda items under their purview.
